Course Duration

3-day public or single organization course. Can also be combined with COBIT 5 Implementation as a 5-day class-based course, or taken as an online self-study option.

Overview

Objectives

The course provides knowledge of the key principles and concepts of COBIT 5, specifically in the following areas:

- The major drivers for the development of COBIT 5.
- The business benefits of using COBIT 5.
- The COBIT 5 Product Architecture.
- The 5 key principles of COBIT 5 for the governance and management of enterprise IT.
- How COBIT 5 enables IT to be governed and managed in a holistic manner for the entire enterprise.
- How the COBIT 5 processes and the Process Reference Model (PRM) help guide the creation of the 5 Principles and the 7 Governance and Management Enablers.
- The basic concepts for the Implementation of COBIT 5.
- The basic concepts of the new Process Assessment Model.
- The COBIT 5 guides and how they interrelate.

Course Format

This is an instructor led classroom course that uses a combination of lectures, group discussions, quizzes and sample exams to provide the student with a foundation understanding of the essential aspects of COBIT 5 and to prepare them for the COBIT 5 Foundation Certificate examination. The course culminates in a formal closed book, multiple choice examination comprising 50 questions lasting for 40 minutes. The pass score is 50% (25 out of 50).

Who should attend?

This course is for business managers, chief executives, IT/IS auditors, internal auditors, information security and IT practitioners; consultants, IT/IS managers requiring an insight into the enterprise governance of IT and eventual certification as a COBIT implementer or assessor.

Professional Qualification

The COBIT 5 Foundation Certificate, which is a pre-requisite for both the COBIT 5 Implementation certificate and the COBIT 5 Assessor certificate. The examination is a 40-minute, closed-book, multiple choice paper, normally taken at the end of the course.

Structure

The course is primarily lectured based, with assignments to reinforce the key learning topics, and largely based on the COBIT 5 Framework for Business guide.

- Change enablement

- The reasons for assessment
- The related standard and purpose of the COBIT 5 assessment guides
- The levels of assessment
