Course Format

Professional Qualification

The qualification is based on a 1-hour-40-minute, closed-book, multiple-choice exam comprising 50 questions. The passing score is 65%. Some students may be entitled to additional time – your course director can give more details if required.

- Enables delegates to understand the different between prevention and resilience (the ability to recover from damage or misfortune), and aspects of prevention, detection and correction
- Governance and an enterprise approach to risk management (focus on cyber security)
- Strategic approach of perspective, position, plans and patterns
- Risk management and risk treatment plan (links to ISO9001 and ISO27001)

- Managing cyber resilience across the service lifecycle:
 - Cyber resilience continual improvement and 7-step process
 - Cyber resilience strategy and processes
 - Cyber resilience design and processes
 - Cyber resilience transition and processes
 - Cyber resilience operation and processes
